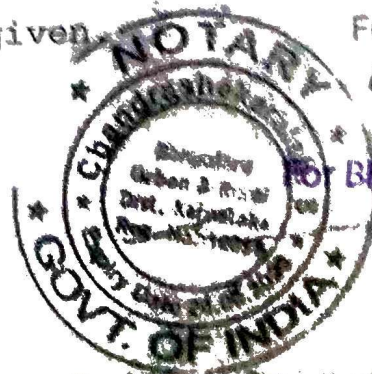

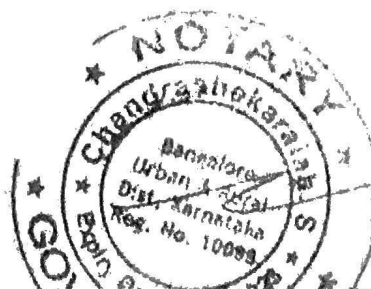

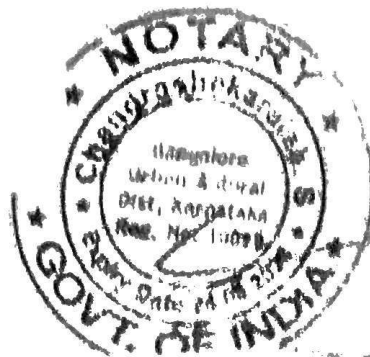
1. Under Children RTE Act 2009 and Karnataka Education act 1983 and under it framed rules, the school is registered, to the registered school classes the recognition is renewed (primary education, secondary education) 1 to 5th (1 to 5,



1 to 8, 6 to 8, 9 and 10 and 1 to 10th) except these school classes, there is no permission for additional classes and additional sections.

2. The school should be maintained as per Karnataka Education act 1983 and RTE Act 2009.

3. Under the RTE Act 2009 framed rules, 25% of the seats to weaker section children is to be reserved and the schools coming under the RTE, the Government reserved seats under RTE to admit is having powers (Government Children parents residing neighbouring school to give admission this rules are framed to make it convenient. Accordingly Government and from Govt. obtaining aid educational institution if exist to that school the children should be admitted, otherwise the private school from the Govt. admitted children is to be given admission and in the primary level to continue the education, opportunity should be given, and these children

without any disparity for continuing education should make provision.

4. Under paragraph-3 explained, the children admitted under the RTE rules their fees as per the rules the Government will release. And hence from these children collecting any kind of fee is prohibited.
5. School and School Management should not collect any kind of capitation fee and voluntarily given donations from the parents at the time of admission of students nor later in any manner collecting is prohibited.
6. The School/Management, in their school from the parents of the children towards the tuition fee collecting fee information has come to the notice of Government under Govt. Notification ED 31 PGC 2019 dt.27.7.2019 the information in the Departmental website and school notice board should be published. Excessive collection of fee then the prescribed fee should not be done.

7. The School/Management should admit the students as per the Government prescribed period.

8. School/Management against the following factors should not refuse the admission

(i) lack of the age proof

(ii) Caste, Religion, place of birth, language

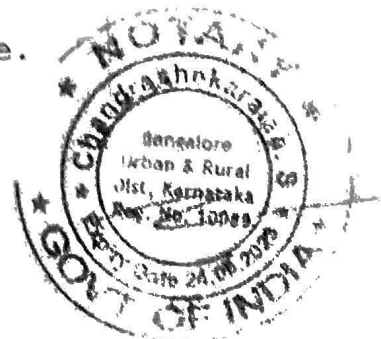
(iii) If beyond the area the admission is sought.

9. RTE Act and rules, Karnataka Education act and Rules, all safety measures should be undertaken, and from the concerned authorities fire safety and building safety certificate and as per the KSC PCR and NCPCR the children safety.

10. The School/Management as hereunder;

i) Any child who have obtained admission in the school till Primary Education and Middle Education is completed in any of the class should be withheld or should not be sent out of the school.

ii) The child should not be given any kind of physical and mental torture.



- iii) Till the primary education is completed any of the child need not pass any Board examination.
- iv) Till the primary education is completed for every child as per RTE rule 21 and Karnataka Education Act and rules as prescribed the Certificate will be given.
- v) The appointed teachers as per RTE Act and rules and as per Karnataka Education Act and rules and Government orders, to the Primary and Secondary Education prescribed minimum qualification should be held.
- vi) To the students payable salary and allowances and the service rules and condition, as per the instructions of the State Government and the Govt. Notification (PF) and the payable Bank and other payments the payment should be paid to teachers, and to the Employees State Insurance.
- vii) The teachers as per section 24(1) and RTE Act and rules and as per Karnataka Education act



and rules, under rule 17 directed duties is being carried out and for the supervision consideration private tuitions should not be done.

11. The school should adhere to the Syllabus and Text Books as prescribed by Education Authority.
12. Under Section 19 of the Karnataka Education act and rules, on the basis of the facilities available in the school the admission to the students is to be given.
13. As prescribed under section 19, the school rules and guidelines should be followed, as per the Karnataka Education act and rules the departmental staff should be appointed.
14. In the school premises or outside unauthorized classes/sections (branches) should not be opened.
15. Pertaining to the school building and other infrastructure facilities should not be given

- during day or night for any commercial activities or political and non educational activities.
16. The school should not be run for the profit of any person or group or society.
 17. The books of account of the school should be audited by chartered accountant and the copy of the same every year before the end of June should be sent to Deputy Director/BEO.
 18. Government Notification (Kannada Language policy 2016) the school should following the language policy.
 19. As per the RTE Act and Karnataka Education act and rules the Management and Teachers should carry out the work.
 20. Schell/Management Government and Department rules and directions should be followed without fail.
 21. Before the end of March every year, in SITS the school information should be updated and the same is mandatory.



22. If any of the conditions cited above is violated as per the RTE Act 2009 and Karnataka Education Act 1983 framed rules, the recognition of the school will be cancelled.

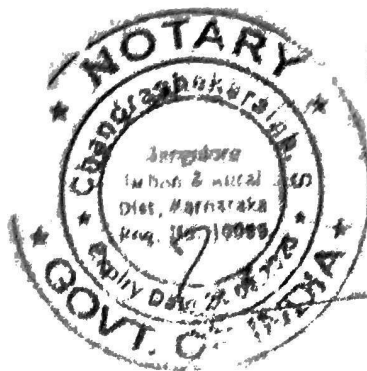
